


1. Go to the following internet page

2. Click „Your EU Login account“.
3. Select your preferred language and
4. click „Create an account“.

In this example: account creation using email but you can create an account also using your Facebook, Google or Twitter.




5. Enter the necessary data, read the data protection declaration and mark the click box „Data protection declaration read“.

Enter the code (case sensitive, the code generator may have to be restarted, it often does not work right away.)

- The EU reply email can take a few minutes or up to 12 hours.
If necessary, search in your SPAM folder



1. At the top, if required, select the language by clicking on "English", a list is displayed. Click language.

Attention: If you change the language later, some, but not all, of the entries disappear and have to be selected again.

2. Read introduction, read guidance

3. Fill in "About you": Select language, select type of participation, either "as an EU citizen (EU citizen) or as an NGO (if applicable), name, email, select country, economic sector (the entire industry is summarized under "Manufacturing").

4. Select Publication privacy settings: Anonymous or Public.

Examples:

- My children convinced me (us) of a vegetarian (vegan) diet. I (we) want to try it out
- We will increasingly do video conferencing instead of traveling to customers and offices. We tried that during Covid-19. Our costs are much lower and our employees have more time for our customers.
- We will increasingly offer Office from Home solutions for our employees.
- I will walk for distances less than 2 km
- I do trips under 5 km by bike
- I will use more public transport offers
- We will install a photovoltaic system on our house and thus contribute to local electricity generation.
- I will no longer travel distances up to 1000 km by plane.
- I would be ready to
 - spend more money on organic, regional food
 - no longer fly
 - less to buy new things and repair broken ones
 - to use my technical devices for longer
 - reduce plastic (buy unpacked)
- I eat vegan, buy plastic-free as possible, only deposit bottles, increasingly organic. I drive less car (LPG, -30% CO2), more bike as soon as the 365 € ticket comes, more often with public transport. I don't fly. The next car will be a small electrical car! I bring sorted things to the social store. I only heat to 19 ° C. My energy is green. My employer must be in the EE or green (train). I am involved in the climate movement (P4F), disseminate climate knowledge on Instagram & demos.

Summary Green Deal

The Green Deal is the implementation of the Paris Agreement at European level and was published in December 2019. The EU is aiming for net zero by 2050 at the latest. The Green deal fits into the strategy to move to a resilient economy within the planetary boundaries. Politicians act now, pandemic recovery is linked to stabilize the planet and the economy, announcements of Net Zero 2040 or 2050 are made. Market will consequently reallocate investment on these long term goals very fast [2].

There are currently two roughly equally strong force fields in the EU:

- progressive forces aiming for > 55% CO₂ reduction targets by 2030 and
- conservative forces who believe that 40% is more than enough.

The fossil lobby massively supports the latter. Therefore, the climate justice movement can and must provide a strong impetus to develop the EU faster and more comprehensively into a fair and climate-neutral society.

As part of the development of a comprehensive climate protection law, the EU is carrying out several open reports. Citizens and lobby organizations can express themselves here. Everyone in the world, regardless of age, place of residence and nationality, has the chance to intervene up to the respective deadlines using a form on the EU side.
